The Dementias: It's Not Always Alzheimer's Disease

More than 35 million people in the world suffer from Alzheimer's disease, including over 5.3 million individuals in the United States. Alzheimer's disease is the most common form of dementia among the elderly, accounting for approximately 60% of all dementia cases. Hence, 40% of dementia cases have a different etiology. No biomarker or diagnostic test is available to distinguish among the different forms of dementia. Consequently, it is critical to understand the clinical presentation of these non-Alzheimer's disease dementias.

The broad goal of this conference is to introduce the clinical, molecular, and neuropathological differences that distinguish the different dementias (Alzheimer's disease, Lewy body dementia, frontotemporal dementia, vascular dementia and Parkinson's disease dementia), and to discuss neuropathological differences and treatment strategies. 1 in 8 individuals over the age of 65 will have dementia, but currently over 70% of individuals with dementia do not ever receive a clear diagnosis. Most older adults (including those with Alzheimer's disease), receive their medical care from primary care and other community physicians who often lack the clinical diagnostic information necessary to accurately determine the type of dementia afflicting the presenting patient.

Also important, and frequently overlooked in the clinical process, is the importance of social service resources imperative in planning optimal care when treating this burgeoning and demanding population.

Continuing Medical Education Objectives

- ▶ Integrate the different etiologies and neuropathologies underlying age-related dementias, and distinguish the diagnostic and treatment options available for the different dementias.
- ▶ Evaluate the range of efficacy of current treatment options, the latest advances in research and the areas that require further investigation. Apply increased knowledge of all available treatment strategies which would facilitate improved patient outcomes.
- ▶ Assess the scope of social services assistance and resources available in the community, to enhance the patient and family caregiving experience, and consequently improve outcomes.

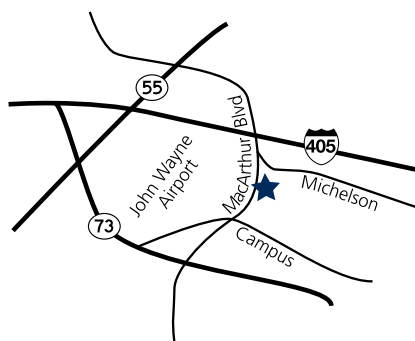
